<b>ALSO:*Previous speeding conviction in 12 months = add \$50</b>		
<b>*2 or more previous speeding convictions in 12 months = add \$100</b>		
<b>*Construction zone = fine above is doubled</b>		
<b>OVI (formerly DUI) .....</b>	<b>\$500</b>	<b>MUST APPEAR IN COURT</b>
