

RESOLUTION NO: 19-06

ADOPTED: July 23, 2019

A RESOLUTION TO PROCEED WITH PLACING THE ISSUE ON THE BALLOT FOR A ONE-HALF (0.50) MILL, FIVE (5) YEAR REPLACEMENT TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION FOR PARKS AND RECREATIONAL PURPOSES AND DECLARING AN EMERGENCY

WHEREAS, with Resolution 19-04, adopted March 25, 2019, Council for the Village of Thornville, Ohio determined the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Village, and it is necessary to replace a one-half (0.50) mill, five (5) year tax levy, in excess of said ten-mill limitation, for the purpose of parks and recreation, pursuant to R.C. 5705.19(H), R.C. 5705.191, and R.C. 5705.192; and

WHEREAS, with Resolution 19-04, adopted March 25, 2019, Council for the Village of Thornville, Ohio requested from the Perry County Auditor a Certificate of Estimated Property Tax Revenue indicating how much revenue will be provided by the one-half (0.50) mill replacement tax levy; and

WHEREAS, on April 30, 2019, the Perry County Auditor certified that the dollar amount of revenue that would be generated by the one-half (0.50) mill replacement tax levy is \$57,500.00 annually during the life of the levy, assuming the total current tax valuation (\$23,144,960.00) remains the same throughout the life of the levy.

NOW, **THEREFORE, BE IT RESOLVED** by the Council for the Village of Thornville, Perry County, State of Ohio, two-thirds of its members voting as follows:

SECTION 1: The Village of Thornville hereby declares it will proceed with placing the issue on the ballot for a one-half (0.50) mill replacement levy for parks and recreational purposes for a period of five (5) years, commencing January 1, 2019.

SECTION 2: The proposed language on the question of the replacement levy on the ballot shall read as follows or in a manner similar to the following:

A replacement of a tax for the benefit of the Village of Thornville for the purpose of parks and recreation at a rate not exceeding one-half mill for each one dollar of valuation, which amounts to \$0.05 for each one hundred dollars in valuation, for five (5) years, commencing in 2019, first due and collected in the 2020 calendar year.

FOR THE TAX LEVY

AGAINST THE TAX LEVY

SECTION 3: The question approving the replacement levy as set forth in Section 2 shall be submitted to the electors of the Village of Thornville, Ohio at the election on November 5, 2019.

SECTION 4: The Fiscal Officer of the Village of Thornville is hereby authorized and directed to certify a copy of this Resolution to the Board of Elections of Perry County, accompanied by a copy of the Perry County Auditor's certification, and shall include with this certification the rate of the tax levy, expressed in mills for each one dollar in tax valuation as estimated by the County Auditor.

SECTION 5: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

SECTION 6: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its

committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 7: Pursuant to R.C. Chapter 5705, this Resolution shall take effect immediately. In the alternative, Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village needs this Resolution certified to the County Board of Election as soon as possible to make certain it will be accepted by the Board of Election and placed on the November 5, 2019 ballot. Wherefore, provided this Resolution receives the required affirmative votes of Council, this Resolution shall take effect and be in force immediately upon passage by Council.


