

RESOLUTION NO 23-11
ADOPTED November 27, 2023

A RESOLUTION TO ACCEPT THE BID OF, AND EXECUTE A CONTRACT WITH, WIN WASTE INNOVATIONS OF HEATH INC. FOR THE WEEKLY CURBSIDE COLLECTION AND DISPOSAL OF RESIDENTIAL TRASH, REFUSE, AND YARD WASTE WITHIN THE VILLAGE OF THORNVILLE

WHEREAS, the current contract for the weekly collection, transportation and disposal of all garbage, trash, refuse, and yard waste from residential properties located within the incorporated area of the Village of Thornville will expire on December 31, 2023; and

WHEREAS, the Village of Thornville advertised for bids for a new three-year trash contract. Notice was given, pursuant to R.C. 7.16, in the Newark Advocate on June 8, 2023 and June 15, 2023; and

WHEREAS, a Pre-Bid conference for all potential bidders was held on Tuesday, July 18, 2023 at 12 p.m.; and

WHEREAS, the Village received four (4) bids, which were opened on Thursday, August 3, 2023 at 2:00 p.m. at the Thornville Village office located at 1 S Main St, Thornville, Oh 43076; and

WHEREAS, having reviewed these bids, Council for the Village of Thornville believes WIN Waste Innovations of Heath Inc., submitted the lowest and best bid.

NOW, **THEREFORE, BE IT RESOLVED** by the Council of the Village of Thornville, County of Perry, State of Ohio that:

SECTION 1: The Village Administrator and Fiscal Officer are hereby authorized and directed, on the behalf of the Village of Thornville, to accept the bid of, and execute a contract, in substantially the same form and content as the Contract attached hereto as Exhibit A and incorporated herein by reference, with WIN Waste Innovations of Heath Inc., for the weekly collection, transportation and disposal of all garbage, trash, refuse, and yard waste from residential properties located within the incorporated area of the Village of Thornville.

SECTION 2: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.


SECTION 4: This resolution shall take effect at the earliest time allowed by law.
